# Supporting Consumers and Confronting Problematic Billing Practices

If you are a lawmaker concerned about how the corporate transformation of healthcare is impacting patients, this guide shares useful resources and reading materials that can help you and your constituents.

## Consumer Resources

Where can patients with unfair health care bills turn for help?

Resources vary by state, but consumer assistance programs, ombudsmen, and other consumer protection entities can be starting points to determine how best to support patients faced with unfair or incorrect bills.

## **State Resources**

### Consumer Assistance Programs (CAPs)

- The Affordable Care Act established CAPs, with a mission to help consumers access their insurance benefits. CAPs assist consumers with insurance issues, including the exercise of their appeal rights, via phone, mail, email, and/or in-person aid.
- Although federal funding is no longer available for CAPs, currently 38 states operate at least one CAP.

#### **Ombudsmen**


- Consumers can directly report complaints to an ombudsman. The ombudsman can investigate a variety of complaints, including improper billing practices, unfair or unclear charges, and/or excessive fees.
- Ombudsmen have investigative and mediation authority, but must refer enforcement to another agency.
- States may have an ombudsman for insurance plans in the state, the Medicaid program, or for specific population groups. For example, the Older Americans Act requires all states to have an Ombudsman Program for complaints specific to long-term care. Find your state's long-term care program with the state ombudsman map from the National Consumer Voice for Quality Long-Term Care.

#### Other Potential State Sources

- Some state agencies may collect, investigate, and enforce complaints of unfair billing practices on behalf of patients.
  - The specific agencies and authority vary state by state, though common agencies include Attorneys General, Departments of Insurance, Departments of Financial Services, Departments of Health, Departments of Human Services, and/or Consumer Protection Divisions.



- Fifty state resources on some of these agencies are available: <u>CDC Accredited Health Departments</u>, <u>NAIC Insurance Departments</u>, <u>NAAG Attorneys</u> <u>General</u>, <u>State Consumer Protection Offices</u>, and the Association of Health Care Journalists' <u>50-State</u> <u>Guide to Health Insurance</u>.
- Media attention can also assist and educate consumers, though the impact can be more limited. Several media outlets investigate problematic billing and patients' experiences: KHN Bill of the Month, NYT Health, An Arm and a Leg podcast, and NPR Health Care.



## Federal Resources

- The <u>Employee Benefits Security Administration</u> assists and educates consumers about their job-related benefits, including health.
- The Department of Justice Antitrust Division facilitates an online portal to collect complaints about anticompetitive practices, available at <a href="https://example.com/HealthyCompetition.gov">HealthyCompetition.gov</a>.
- The Consumer Financial Protection Bureau collects complaints about medical debt collection practices.
